Errata as of December 22, 2023

PADD 2 propane/propylene stocks are overstated in the November 15, 2023, through December 20, 2023, publications of the *Weekly Petroleum Status Report* (WPSR), which corresponds to the weeks ending November 10, 2023 through December 15, 2023. We have made the necessary corrections for future weeks and provided corrected values in the WPSR Appendix E Errata table (below). The stock error also affects calculated quantities of stock change and product supplied for propane/propylene, total petroleum, and other oils.

We will not republish past editions of the WPSR to incorporate this corrected data. However, for the week ending December 15, 2023, we will use the corrected data, including all impacted data series, for difference and average calculations in future WPSR publications, including the difference from a week ago, one year ago, and two years ago, as well as the four-week averages.

We will release finalized data for November and December 2023 as part of the *Petroleum Supply Monthly* (PSM) at the end of January and February 2024, respectively.
