AEO2016 vs AEO2015 changes in LFMM

Crude

- Crude exports are allowed, unrestricted
- Revised methodology for determining by-grade crude price response

Products

- Modified elasticities representing international product import and export curves (IEM)
- All product curves are extended to 14 steps

Logistics

Updated pipeline and rail capacities and tariffs


Policy

- Reinstated ethanol and biodiesel tax credits through 2016
- New RFS issued November 2015
- Updated pricing of fuel oil in Census Division 9


Real Petroleum Prices: Crude Oil: Brent Spot (2014 \$/b)





Brent-WTI spread


Real Petroleum Prices: Crude Oil: Brent vs. WTI Price Spread (2014 \$/b)





Motor gasoline price


Real Petroleum Prices: Transportation: Motor Gasoline (2014 \$/gal)





Diesel fuel price


Real Petroleum Prices: Transportation: Diesel Fuel (2014 \$/gal)


Liquid Fuels: Crude Oil: Domestic Production (MMb/d)

Net imports of crude oil


Liquid Fuels : Crude Oil : Net Imports (MMb/d)





Crude oil exports (mainly to Canada)


Liquid Fuels: Crude Oil: Exports (MMb/d)


Liquid Fuels: Net Product Imports: Exports (MMb/d)





Net import share of product supplied


Liquid Fuels: Net Import Share of Product Supplied (percent)






Refinery utilization

Liquid Fuels : Capacity Utilization Rate (percent)






Motor gasoline consumption declines, with small increase in E85 consumption






Total ethanol production remains steady, with lower levels from cellulosic sources
