Because of the changes made to the 2014 MECS, the quantity in 'Other' for the petroleum refineries in Tables 1 and 2 is now less than it would otherwise be using the previous method. Similarly, the quantities in 'Other' for Chemicals (NAICS 325 and certain subindustries) and the asphalt industries (NAICS 324121 and 324122) are now larger than they would otherwise be under the previous method. Because of the changes made to the 2014 MECS, the quantity in 'Other' for the petroleum refineries in Tables 1 and 2 is now less than it would otherwise be using the previous method. Similarly, the quantities in 'Other' for Chemicals (NAICS 325 and certain subindustries) and the asphalt industries (NAICS 324121 and 324122) are now larger than they would otherwise be under the previous method.
